#### ORDINANCE NO. 2014-\_\_\_\_

#### AN ORDINANCE WAIVING COMPETITIVE BIDDING REQUIREMENTS AND AUTHORIZING THE BRYANT STREET DEPARTMENT TO ENTER INTO AGREEMENTS WITH TEMPLE, INC. AND ALL SERVICE ELECTRIC, INC. FOR THE REPAIR AND REPLACEMENT OF THE ELECTRIC CONTROL BOX FOR THE TRAFFIC LIGHT AT MILL PARK ROAD AND REYNOLDS ROAD

WHEREAS, the City of Bryant Street Department owns and operates traffic signals within the City; and

**WHEREAS**, the electrical control box for the traffic light located at the intersection of Mills Park Road and Reynolds Road was destroyed in an accident that occurred on March 29, 2014; and

WHEREAS, it is necessary that all City traffic lights operate on the same supervisory now in use; and

**WHEREAS**, Temple, Inc. of Decatur, Alabama has submitted its proposal to provide the cabinet assembly at a cost of \$10,056 and two video processors at a cost of \$6,750 (attachment "A"); and

**WHEREAS**, All Service Electric, Inc. of Hot Springs, Arkansas has submitted its proposal to install the traffic signal base, pedestrian crossing signals, signal heads, conduit, signal cable and video cable and other associated work at a cost of \$14,090 (attachment "B"); and

**WHEREAS**, Temple, Inc. is the sole source supplier of the traffic signal cabinet and assembly in this region; and

**WHEREAS**, All Service Electric, Inc. offered the lowest qualified price quote for the electrical service required for wiring traffic signals in this region; and

**WHEREAS**, §14-58-303 Arkansas Statutes Annotated requires that the governing body by ordinance may waive the requirements of competitive bidding in exceptional situations where this procedure is determined not feasible or practical;

**WHEREAS,** the formal statutory bidding process does not provide sufficient safeguards for the citizens of Bryant in the acquisition of such specialized technology; and

**WHEREAS**, engaging in the bidding process to repair this damaged signalized intersection would create an undue delay and hinders the safe travel of vehicles and pedestrians at this intersection.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRYANT;

**SECTION 1**: That the Mayor or her designee is hereby authorized to execute the Agreement between the City of Bryant and Temple, Inc.

**SECTION 2**: That the Mayor or her designee is hereby authorized to execute the Agreement between the City of Bryant and All Service Electric, Inc.

**SECTION 3**: That no additional funding is appropriated by this Ordinance. Funding for the repair and replacement will be from reimbursement of expenses by insurance payments from the vehicle involved in the accident and from insurance held by the City of Bryant.

**SECTION 4**: That the City makes a finding that an exceptional circumstance exists making competitive bidding neither practicable nor feasible, and that the requirements of competitive bidding should be waived pursuant to 14-58-303(b)(2)(B) Arkansas Statutes Annotated.

**SECTION 5**: That the cost-efficient and reliable restoration of the traffic signal is important to the health, safety and welfare of the citizens of Bryant, and the City should act as quickly as possible to install, setup and commission the necessary hardware and operating systems for the operation and management of the City's traffic signals;

**THEREFORE**, an emergency is declared to exist and this Ordinance shall be in full force and effect from and after its passage.
