ORDINANCE NO. 2018-____

AN ORDINANCE AUTHORIZING PURCHASE OF TRUCKS FOR PARKS; WAIVING COMPETITIVE BIDDING; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, The City of Bryant received an Amendment 78 loan for the purpose of purchasing new Parks equipment, that included 4 new trucks at State Bid pricing, and

WHEREAS, The dealership which was awarded the State Bid Contract is not able to provide the trucks within the specified time due to unforeseen events in production, and

WHEREAS, The dealership is not able to sell trucks that have been manufactured at the State Bid price, and

WHEREAS, The Parks Department is currently responsible to pay the loan payment for the money alloted to trucks, even if the trucks have not been purchased, and

WHEREAS, Everett Buick GMC has 4 trucks immediately available, which meet the needs of the Parks Department, and

WHEREAS, The City of Bryant can purchase these trucks from Everett Buick GMC with the Amendment 78 loan funds, plus an additional \$10,000 transferred from the Parks Department savings to 001-0400-5810

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRYANT;

SECTION 1: The Mayor is hereby authorized to execute any and all necessary documents to effectuate a contract with Everett Buick GMC to purchase 4 trucks.

SECTION 2: Due to the immediate availability and the needs of the Parks Department for trucks, an emergency is declared and this Ordinance shall take effect immediately upon its passage.

SECTION 3: The City Council of The City of Bryant makes a specific finding that an exceptional circumstance exists making competetive bidding impracticable.
