- Esther spoke with Mark Benning with Alexander Youth Center after he originally received a bill with a huge spike in usage.
- Mark requested that the meter be tested.
- The city attempted to test the meter but was unsuccessful due to the size of the water meter. After speaking with Monty and Russell, we decided that we would replace the meter and wait to see the average usage once the new meter was installed.
- While waiting for the old meter to be replaced, it was agreed upon that Alexander Youth Center would pay the bill based upon an average usage for the extremely high months while waiting for the new meter to be installed. The agreement was that if the new meter continued to show high usage Alexander Youth would then pay the remaining amount for the old bills. If the new meter showed that the usage went back down to the normal usage for the Alexander Youth Center we would attribute the large increase to the meter going bad and we would adjust the bills to the average usage for the months involved.
- After the new meter had been installed for several months it was determined that based upon the normal usage with the new meter that we would honor our agreement to adjust the bills with the large increase down to the average normal usage.

## WASTEWATER DISTRIBUTION

Wastewater crews have completed about 30 work orders in the as of May 22. Crews inspected 40 manholes while searching for Inflow and Infiltration. 6200 feet of sewer line were cleaned. Other activities include marking parking spaces and installing parking blocks at the Operations Building, installing a new 1000 gallon fuel storage tank. The I\&I crew helped the water crews on six water leaks and cleaned 12 storm drains for the street department.
