Call to Order: The meeting was called to order by Chairman Wade Boone

Financials: The December Financial Report was delivered to the Committee. The report is the end of year

budget status report but not the final reconcillitation since some bills are still coming in from 2014.

Citizen's Concerns: Jesse Forrester- 8007 North Haven - Mr. Forrester is on Salem Water and Bryant Sewer. He had an

unexplained high water bill from the Salem system. The bill went up and then dropped back down the following month. He asked if there was any relief available on his sewer bill. Kathy Barber moved to adjust the sewer portion of the leak to the average usage. The motion was seconded by

Alan Kays. Motion carried.

By motion of Kathy Barber and second by Alan Kays, the Committee approved the following billing

adjustments:

Fast Enterprises - 105 SW Forth Street - a water hose was left running causing a high bill. Though

not over \$100 Buddy Fowler brought the adjustment to the Committee for approval.

By motion of Jack Moseley and second by Kathy Barber, the Committee approved the following billing adjustments for October, the first month after the Water Department notified customer of a

leak.

Adria Tacker- 2306 Amber - Customer was notified in September that the AMI system had detected a leak. Customer did not contact Customer Service until December and did not repair leak until

January.

New Business: Credit Card Fees - Joy Black introduced discussion of whether the City should impose a surcharge

for use of credit cards to pay bills. It is a complicated issue. The city uses a company that is a preferred provider by our financial software. That company charges a fee for online payments

through the City's website. The billing office does not charge a fee when paid in person. There is a \$5 fee charged when customers pay over the phone. In 2014 the Water and Wastewater Department paid approximately \$47,000 to credit card providers. Credit card companies typically charge about 3% to the merchant. Debit cards charge about 1%. The cost of those fee comes out of revenues, so it costs us to allow use of credit cards. The complication is that different credit card companies have different service agreements that are in conflict regarding imposition of surcharges. Mike Chandler suggest accepting only one credit card rather than multiple cards. Joy did not ask the Committee to make any decisions, but rather wanted to introduce the subject for future discussion and possible recommendations.

**Hunters Crossing Subdivision** - Monty told the Committee that the new subdivision is located on Highway 5 near the new water tank. The Health Department has approved the plans for water and sewer utilities. Monty recommended that the Committee vote to accept ownership of the water and sewer mains pending confirmation of approval by the Health Department and compliance with Bryant Minimum Standards for construction.

## **ANRC Projects**

- The 16" Water Main project is complete except for repair of a leak on the Central Arkansas Water side of the project.
- The Snooks Lane Water Main Extension will hopefully start construction in early February. One of the properties belonged to someone who passed away. The heirs have been contacted. The sister of the gentleman will be appointed Power of Attorney in the next couple of weeks. She has agreed to sign the easements at that time
- The 12" Sewer Force Main project is waiting for acquisition of the remaining easements before construction can begin.

**SSES Quarterly Report** 

Scott Chandler provided the year end Quarterly Report for sanitary sewer overflows. Monty and Scott also told the Committee about a diagnostic system being investigated for use in identifying sewer lines that need maintenance. The system uses sound to identify blockages. A transmitter is placed in one manhole and a receiver is set up in a sequential manhole. The system measures the quality of the sound received and can indicate whether obstructions exist and rate the severity of the obstruction. The tool will save unnecessary cleaning of lines that do not need attention.

**Comments:** 

Kathy Barber noted that she had signed up for the email alerts from the AMI system but had not received any alerts. Monty noted that he had a similar problem because he did not "save" his sigh up information. He suggested that might be the reason she was not receiving alerts.
