Call to Order: The meeting was called to order by Vice-Chairman Jack Moseley. Chairman Boone arrived shortly thereafter

Financials: The most recent Budget Status Report was provided to the Committee. Joy Black informed the committee

Citizen's Concerns: Buddy Fowler presented requests for billing adjustments. Customer Service made four adjustments under

the \$100 threshold. There were seven request that exceeded \$100. The customers provided all required

documentation.

New Business:

Standard Specifications for Water and Sewer Construction - The full document is 248 pages, attached to the email sent out. The document is being edited by staff at this time. Central Arkansas Water Negotiations -Central Arkansas Water has lost a couple of customers on the north end of their system. They are offering Bryant an additional 1.5 MGD on our contract along with an increase in the minimum take or pay amount in the contract. Some negotiations will be needed before the contract is amended.

B. Old Salem Subdivision - Creekside Cottages - The developer will appear at City Council on March 31 to request sewer services from Bryant. The subdivision is outside the City Limits but will sign an agreement to annex at the first available time.

Consumer Confidence Report - A copy of the annual report for 2014 was provided. The report must be delivered to customers by July 1 each year. The report will be included in the April billing statements.

Senate Bill 540 - the bill would require Cities to consider PVC and Ductile Iron as equal with some exception based on "sound engineering practices". Monty wrote a letter to several House members urging them to reject the bill in favor of letting local entities make the decisions based on conditions rather than state

mandate. The bill failed in the House.

Old Business: Credit Card Fees - We continue to investigate the use of credit cards. Fees from Visa, Master Card and

Discover are all due to go up slightly in the next few months. The issue continues to be complicated.

Reports: WATER - Water crews have repaired 18 service leaks, 5 new construction taps and one main break in

recent weeks. We do about 20 to 30 locates a day. The new Aspen Dental water tap is complete. The CVS

Pharmacy required 4 taps.

WASTEWATER - Wastewater crews have completed about 105 work orders in the first quarter, Along with assisting water crews with many of their projects. We have reported a total of 4 SSO's for the first quarter of 2015; one equipment failure, two blockages and one line failure. Our flow study has shown basin # 5 has the highest amount of I&I throughout our collection system at this time. Crews have been actively searching for I&I issues by walking the neighborhoods in basin # 5 and have found two Major points of infiltration and many minor points which will be prioritized and repaired. These are surface visible issues. Once these have been addressed crews will begin smoke testing and CCTV mains looking for the not so obvious. Crews have inspected about 150 manholes in basin #5 and found private service lines to be a contributor to our I&I issues also. I have spoken with some of our customers at this point with the request for them to make necessary repairs.

ANRC Projects

- The 16" Water Main is online and working great. We were recently able to pump water to our tanks at a rate of 5.1 MGD.
- The Snooks Lane Water Main Extension is near completion.
- The 12" Sewer Force Main project is still waiting for acquisition of the remaining easements before construction can begin. The holdup is one property involved in an estate. That should be resolved soon.
