ADEQ should renew his permit in the near future. We did not approve a portion of his last pay request. There is approximately \$111,000 remaining on the contract.</li> <li>New Regulations from ADEQ - We continue to sample hardness, zinc and copper to propose less stringent limits to ADEQ prior to November 2016 when the effective treatment limits go into effect. Consent Administrative Order - The plan we submitted to ADEQ in lieu of their imposing a CAO was rejected. ADEQ accepted the fine reduction but rejected our Correction Action Plan. We will meet with Chris Madison and Craig Johnson of Crist Engineers to develop a response.</li> <li>AHTD Highway 5 Widening Project - Crist Engineers has submitted their engineering plans to AHTD and the Health Department for approval. The Health Department has approved plans. We are awaiting the AHTD approval. It is anticipated that construction will begin in September or October and continue into 2017.</li> <li>Leak Detection Project - We are renewing our interest in the leak detection project. The debate at this time is whether we do a demonstration study first at approximately \$20,000-\$30,000, or purchase the equipment at approximately \$350,000.</li> </ul>
