Submit Copy of completed Public Notice
Publication: Public Notice shall be published at least one (1) time fifteen (15) days prior to the public hearing at which the variance will be heard. Once published please provide a proof of publication to the Community Development office.
Posting of Property: The city shall provide a sign to post on the property involved for the fifteen (15) consecutive days leading up to Public hearing. One (1) sign is required for every two hundred (200) feet of street frontage.
<ul> <li>Submit eight (8) Copies of the Development Plan (Site Plan) showing:</li> <li>Location, size, and use of buildings/signs/land or improvements</li> <li>Location, size, and arrangement of driveways and parking. Ingress/Egress</li> <li>Existing topography and proposed grading</li> <li>Proposed and existing lighting</li> <li>Proposed landscaping and screening</li> <li>Use of adjacent properties</li> <li>Scale, North Arrow, Vicinity Map</li> <li>Additional information that may be requested by the administrative official du to unique conditions of the site.</li> </ul>

Once the application is received, the material will be reviewed to make sure all the required information is provided. The applicant will be notified if additional information is required. The application will then go before the Development and Review Committee (DRC) for a recommendation to the Planning Commission. A public hearing will be held at this meeting for comments on the Conditional Use. After the public hearing, the Planning Commission will make a decision on the use.
