Product Description and Use:

The natural floating degreaser will be used to prevent grease build-up in wastewater collection system lift stations.

The product must be a natural solution containing a minimum of 95% D-limonene with a color indicator, biodegradable, non-emulsifying, and safe for the environment.

Natural Floating Lift-station Degreaser Specifications:

- NFPA Health Rating no greater than 1
- NFPA Flammability Rating no greater than 1, with flash point >210 degrees Fahrenheit
- NFPA Instability rating of 0
- The product must contain a color indicator providing a visual of the product level in lift stations
- The product must float on the surface of the water
- The product must not contain Petroleum Distillates
- VOC content must be less than 7%
- Product must not be toxic to aquatic life
- Product must contain a minimum of 95% D-limonene
- SDS must be included with the bid
