ORDINANCE No. 2010 - 29

AN ORDINANCE TO AMEND THE 2011 WATER RATES AND ORDINANCE No. 2009-27 AND FOR OTHER PURPOSES

WHEREAS, Bryant Ordinance No. 2009-27 established water rates scheduled to take effect January 1, 2011; and

WHEREAS, the Council has determined to change said rates as follows.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRYANT, ARKANSAS, SALINE COUNTY:

Section 1. Section 1 of Ordinance No. 2009-27 is hereby amended to read as follows:

SECTION 1(b): For water service billed by the City after January 1, 2011, the amount to be paid by each customer shall be computed in the basis of the following schedule of rates:

For the first 2,000 gallons of water consumption per month or portion thereof:

SECTION 1(c): For water service billed by the City after January 1, 2012, the amount to be paid by each customer shall be computed on the basis of the following schedule of rates:

All water consumption in excess of 2,000 gallons: \$4.94 per 1,000 gallons.

Section 2. General Repealer

All ordinances, resolutions, and parts thereof in conflict with this ordinance are hereby repealed to the extent of such conflict.

Section 3. Severability

Should any section, clause, or phrase of this ordinance be declared by the courts to be invalid, that validity shall not affect the other provisions of this Ordinance which shall be given effect without the invalid provision or application, and to this end, the provisions of this Ordinance are declared to be severable.

Section 4. Emergency Clause

To prevent the rates established by Ordinance No. 2008-36 and 2009-27 from becoming effective before the amendments contained in this Ordinance take effect, the City Council hereby declares an emergency and this Ordinance shall be in full force and effect immediately upon its passage and approval.
