ORDINANCE NUMBER 2011-06

AN ORDINANCE AMENDING THE COMPREHENSIVE ZONING ORDINANCE OF THE CITY OF BRYANT TO REZONE CERTAIN PROPERTY FROM R-2 & C-2 TO C-2.

BE IT ORDAINED BY THE CITY COUNCIL OF BRYANT, ARKANSAS;

- Section 1. That certain real property described more fully below is hereby rezoned from a classification of R-2 & C-2 to C-2 located in Ward 1.
- Section 2. The comprehensive zoning ordinance and map of the City of Bryant is hereby amended to reflect the change of zoning classification set out in Section 1.
- Section 3. The property affected by this ordinance is described as:

PARCEL #2: Part of the SE Quarter and part of the East Half of SW Quarter and part of the East Half of SW Quarter all in Section 14, T-1-S, R-14-W, Saline County, Bryant, Arkansas, and lying North of the Interstate 30 Highway right of way (R/W 300'), more particularly described as Commencing at the East Quarter corner of said Section 14; thence S 02 Degrees 24 Minutes 04 Seconds W along the East line of said SE Quarter, Section 14 33.26 feet to the Northerly R/W line of said Interstate 30 Highway; thence S 65 Degrees 08 Minutes 40 Seconds W along said Northerly R/W 1319.06 feet to the Point of Beginning; thence continue S 65 Degrees 08 Minutes 40 Seconds W along said Northerly R/W 2293.58 feet to the Northeasterly R/W of Brittenum Road Crossover; thence in a northwesterly direction along said Northeasterly R/W the following courses N 46 Degrees 51 Minutes 13 Seconds W 103.02 feet; thence N 01 Degrees 45 Minutes 13 Seconds W 251.40 feet; thence N 25 Degrees 11 Minutes 27 Seconds W 156.56 feet; thence N 52 Degrees 56 Minutes 33 Seconds W 201.29 feet; thence N 86 Degrees 06 Minutes 25 Seconds W 295.59 feet; thence N 89 Degrees 36 Minutes 50 Seconds W 114.81 feet to the westerly R/W of said Brittenum Road Crossover; thence S 01 Degrees 42 Minutes 16 Seconds W along said westerly R/W 590.73 feet; thence continue along said westerly R/W S 06 Degrees 20 Minutes 26 Seconds W 378.34 feet to the Northerly R/W of Interstate 30 Highway; thence S 65 Degrees 08 Minutes 40 Seconds along said Northerly R/W 220 feet to the West line of the E Half of the SW Quarter of said Section 14; thence N 02 Degrees 37 Minutes 15

Seconds E along said west line 2075.27 feet to the NW corner of said E Half, SW Quarter; thence S 87 Degrees 42 Minutes 20 Seconds E along the North line of said E Half, SW Quarter 1111.06 feet to the west line of a cemetery; thence S 02 Degrees 22 Minutes 33 Seconds E along said west line of said cemetery 244. 91 feet to the SW corner of said cemetery; thence S 87 Degrees 42 Minutes 26 Seconds E along the south line of said cemetery 181.63 feet to the SE corner of said cemetery; thence N 02 Degrees 27 Minutes 42 Seconds E along the east line of said cemetery 244. 91 feet to the North line of said E Half, SW Quarter; thence S 87 Degrees 42 Minutes 40 Seconds E along said north line 28.0 feet to the center of said Section 14; thence S 87 Degrees 41 Minutes 34 Seconds E along the North line of SE Quarter of the said Section 14, 1475.30 feet; thence S 02 Degrees 24 Minutes 21 Seconds W 635.44 feet to the Point of Beginning, containing 74.61 Acres, more or less.

PARCEL #3: part of the SE Quarter and part of the SE Quarter of the SW Quarter, all in Section 14, T-1-S, R-14-W, Saline County, Bryant, Arkansas, and lying S of the Interstate 30 Highway R/W, more particularly described as: Commencing at the East Quarter corner of said Section 14; thence S 02 Degrees 24 Minutes 44 Seconds W along the E line of said SE Quarter, of said Section 14 372.17 feet to a point on the Southerly R/W of said Interstate 30 Highway, said point being the Point of Beginning; thence continuing S 02 Degrees 24 Minutes 44 Seconds W along said E line of said SE Quarter of said Section 14 2275.62 feet to the SE corner of said SE Quarter; thence N 87 Degrees 50 Minutes 36 Seconds W along the South line of said Section 14 3313.65 feet to the Easterly R/W of Brittenum Road Crossover; thence N 15 Degrees 06 Minutes 40 Seconds E along said Easterly R/W 67.57 feet; thence N 01 Degrees 52 Minutes 00 Seconds E along said Easterly R/W 431.68 feet; thence N 26 Degrees 47 Minutes 20 Seconds E along said Easterly R/W 131. 34 feet to the Southerly R/W of Interstate 30 Highway; thence N 65 Degrees 09 Minutes 42 Seconds E along said Southerly R/W 3654.23 feet to the Point of Beginning, containing 108.54 acres, more or less.
