RESOLUTION No. 2011 - 35

**A RESOLUTION AUTHORIZING THE MAYOR TO PURCHASE AND ACCEPT
EASEMENT FOR PART OF THE NORTHEAST QUARTER OF THE SOUTHWEST
QUARTER OF SECTION 14, TOWNSHIP 1 SOUTH, RANGE 14 WEST, SALINE
COUNTY ARKANSAS**

WHEREAS, the City of Bryant, Arkansas desires to purchase and accept the easement described as follows:

Part of the Northeast Quarter of the Southwest Quarter of Section 14, Township 1 South, Range 14 West, Saline County Arkansas more particularly described as follows;

BEGINNING at a point being used as the Northwest Corner of the Northeast Quarter of the Southwest Quarter of Section 14, said point also being the Southwest Corner of the Town of Collegeville; thence South 87° 43' 22" East along the north line of said Northeast Quarter of the Southwest Quarter of Section 14 and the south line of the Town of Collegeville a distance of 91.58 feet to a point on the easterly right of way line of the Raymar Road North Extension; thence South 4° 36' 35" East along said right of way line a distance of 182.09 feet to a point; thence South 5° 27' 43" West along said right of way line a distance of 125.48 feet to a point; thence South 4° 08' 28" East along said right of way line a distance of 125.40 feet to a point; thence South 0° 25' 58" West along said right of way line a distance of 250.00 feet to a point; thence South 18° 20' 43" East along said right of way line a distance of 52.81 feet to a point; thence South 1° 28' 28" West along said right of way line a distance of 110.02 feet to a point; thence South 1° 36' 46" East along said right of way line a distance of 140.09 feet to a point; thence South 7° 19' 55" East along said right of way line a distance of 125.83 feet to a point on the right of way of Interstate 30 as established by AHTD Job 060688; thence North 86° 07' 28" West along said right of way line a distance of 53.69 feet to a point; thence North 89° 37' 52" West along said right of way line a distance of 114.81 feet to a point; thence South 1° 41' 14" West along said right of way line a distance of 123.45 feet to a point on the westerly right of way line of the Raymar Road North Extension; thence North 6° 12' 17" West along said right of way line a distance of 124.23 feet to a point on the west line of said Northeast Quarter of the Southwest Quarter of Section 14; thence North 2° 36' 13" East along said right of way line and said west line a distance of 331.84 feet to a point; thence leaving said right of way line but continuing North 2° 36' 13" East along said west line of the Northeast Quarter of the Southwest Quarter of Section 14 a distance of 90.06 feet to a point on said easterly right of way line of

the Raymar Road North Extension; thence continue North 2° 36' 13" East along said right of way line and west line a distance of 155.11 feet to a point; thence continue North 2° 36' 13" East along said west line and leaving said westerly right of way line a distance of 529.71 feet to the POINT OF BEGINNING and containing 3.39 acres, more or less, or 147,566 square feet, more or less.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF BRYANT, ARKANSAS THAT:

Section 1. Authorization

The Mayor and City Clerk are hereby authorized by the City Council for the City of Bryant, Arkansas to accept the easement described above.

Section 2. Severability



Section 3. Repealer


All resolutions and other matters in conflict with this resolution are hereby repealed to the extent of any inconsistency.

EASEMENT DEED

KNOW ALL MEN BY THESE PRESENTS:

THAT SPINOFF, INC, AN ARKANSAS CORPORATION, for and in consideration of xxx Dollars, (\$xx.xx), and other valuable consideration, cash in hand paid, the receipt of which is hereby acknowledged, grant, bargain, sell and convey and warrant to the City of Bryant, Arkansas, its successors and assigns forever an exclusive right of way and easement for road purposes on Job WLXL7900 Raymar Road Overpass North Extension, across, through and over the following lands situated in the County of Saline, State of Arkansas:

LEGAL DESCRIPTION

Part of the Northeast Quarter of the Southwest Quarter of Section 14, Township 1 South, Range 14 West, Saline County Arkansas more particularly described as follows;

BEGINNING at a point being used as the Northwest Corner of the Northeast Quarter of the Southwest Quarter of Section 14, said point also being the Southwest Corner of the Town of Collegeville; thence South 87° 43' 22" East along the north line of said Northeast Quarter of the Southwest Quarter of Section 14 and the south line of the Town of Collegeville a distance of 91.58 feet to a point on the easterly right of way line of the Raymar Road North Extension; thence South 4° 36' 35" East along said right of way line a distance of 182.09 feet to a point; thence South 5° 27' 43" West along said right of way line a distance of 125.48 feet to a point; thence South 4° 08' 28" East along said right of way line a distance of 125.40 feet to a point; thence South 0° 25' 58" West along said right of way line a distance of 250.00 feet to a point; thence South 18° 20' 43" East along said right of way line a distance of 52.81 feet to a point; thence South 1° 28' 28" West along said right of way line a distance of 110.02 feet to a point; thence South 1° 36' 46" East along said right of way line a distance of 140.09 feet to a point; thence South 7° 19' 55" East along said right of way line a distance of 125.83 feet to a point on the right of way of Interstate 30 as established by AHTD Job 060688; thence North 86° 07' 28" West along said right of way line a distance of 53.69 feet to a point; thence North 89° 37' 52" West along said right of way line a distance of 114.81 feet to a point; thence South 1° 41' 14" West along said right of way line a distance of 123.45 feet to a point on the westerly right of way line of the Raymar Road North Extension; thence North 6° 12' 17" West along said right of way line a distance of 124.23 feet to a point on the west line of said Northeast Quarter of the Southwest Quarter of Section 14; thence North 2° 36' 13" East along said right of way line and said west line a distance of 331.84 feet to a point; thence leaving said right of way line but

continuing North 2° 36' 13" East along said west line of the Northeast Quarter of the Southwest Quarter of Section 14 a distance of 90.06 feet to a point on said easterly right of way line of the Raymar Road North Extension; thence continue North 2° 36' 13" East along said right of way line and west line a distance of 155.11 feet to a point; thence continue North 2° 36' 13" East along said west line and leaving said westerly right of way line a distance of 529.71 feet to the POINT OF BEGINNING and containing 3.39 acres, more or less, or 147,566 square feet, more or less.

Together with the rights, easements and privileges in or to said lands that may be required for the full enjoyment of the right herein granted.

TO HAVE AND TO HOLD the same unto the said City of Bryant, Arkansas and to its successors and assigns forever.

AND I/We, hereby covenant with the said City of Bryant, Arkansas that I/We will forever warrant and defend the title to said lands and property against the lawful claims of any and all persons whomsoever.

AND I/We, do hereby release and relinquish unto the said grantee all my right of dower or courtesy and homestead in and to said lands.
