

 All that part of the Northeast Quarter of the Northeast Quarter of Section 27, T-51-S R-14-W, Saline County, Arkansas, described as follows: Beginning at a point on the West Line of said 1/4 1/4 that is 629 feet South of the Northeast corner thereof, run thence South, along West Line for 692 feet; thence East, being the Southern corner of said 1/4 1/4; run thence N 88° 54' E along South Line thereof for 1,053.7 feet; run thence N 01° 02' W for 157.4 feet; run thence N 50° 15' E for 207.6 feet to Southern Line of State Highway No. 183; run thence N 53° 45' W along Highway Line for 705 feet to a point that is 629 feet Due South of the North Line of said 1/4 1/4; run thence S 88° 20' W for 706.0 feet to the point of beginning.
