AN ORDINANCE REPEALING ORDINANCE 2017-38; DISSOLVING THE ADVERTISING AND PROMOTION COMMISSION FOR THE CITY OF BRYANT, ARKANSAS; REPEALING THE GROSS RECEIPTS TAX PURSUANT TO THE ARKANSAS “ADVERTISING AND PROMOTION COMMISSION ACT;” AND, FOR OTHER PURPOSES

WHEREAS, the City Council of Bryant passed Ordinance 2017-38 and established an Advertising and Promotion Commission and levied a gross receipts tax, pursuant to the authority of the Arkansas “Advertising and Promotion Commission Act;”

WHEREAS, the City of Council of Bryant wishes to repeal Ordinance 2017-38, dissolve the Advertising and Promotion Commission and repeal the levying of gross receipts tax, pursuant to the authority of the Arkansas “Advertising and Promotion Commission Act;”

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BRYANT, ARKANSAS:

SECTION 1. City of Bryant Ordinance 2017-38 is hereby repealed in its entirety.

SECTION 2. The Advertising and Promotion Commission for the City of Bryant is dissolved immediately upon the effective date of this ordinance.

SECTION 3. The levying of the “gross receipts tax” pursuant to City of Bryant Ordinance 2017-38 and the “Advertising and Promotion Commission Act” within the City of Bryant is repealed immediately upon the effective date of this ordinance.

SECTION 4. Provisions Severable. If any provision of this Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid provision or application, and to this end, the provisions of the Ordinance are hereby declared to be severable.

SECTION 5: Emergency Declared. This Ordinance is necessary to preserve the public peace, health, safety and welfare, an emergency is declared to exist and this Ordinance shall be in full force and effect from and after the date of its passage.
